## STATEMENT

The Clinical Thermometer Section of the National Instruments Ltd. has been suffering losses on account of the cost of production being higher. Stocks have accumulated and the Board of Directors of the Company have decided that further production of clinical thermometers' should be suspended till the stocks are cleared.

The Employees\* Union of the Company submitted a Memorandum containing various suggestions and demands including the one relating to the appointment of a high power Committee to look into the affairs of the Company. There has been a fall in sales and curtailment of production for certain traditional items which is due to a slump in the engineering industries in the country and due to the lowering of the demand from State and Central Government Departments for the items in question. The Company are endeavouring to procure orders from the Defence Department for certain instruments and are taking steps to diversify their production programme to-words line where there is a demand. It is expected that with the diversified programme, the production level will pick up. Both the Management and the Government are already seized of the problem and the question of appointing a Committee to enquire into the working of the Company does not arise.
