RETRINCHMENT IN FCI

*451 SHRIK CHANDRASHEKHA-RAN Will the Minister of FOOD AND AGRICULTURE be pleased to state

- (a) whether it is a fact that the Kerala Regional Office (Southern Region) of the Food Corporation of India proposes to 1 etrench 32 direct recruits in the Keral Region.
- (b) the number of deputationists from various departments of State and Central Governments working in the Kerala Region of the Food Corporation of Indis,
- (c) whether it is a fact that after the date of issue of the retrenchment order two persons on deputation were taken by the Regional Manager on 11th July, 1967, from the State Bureau of Economics and Statistics, and
- (d) whether it is a fact that the direct recruits are being retrenched instead of deputationists being sent back to their parent Departments after terminating the deputation period?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICUL-TURE COMMUNITY DEVELOP-MENT ANTI COOPERATION (SHRI ANNASAHFB SHINDE) (a) Yes, Madam

- (b) Six Grade III Assistants
- (c) Yes, Madam
- (d) No threat recruit has so far been retreached 33 Grade III Assistants were directly recruited on the vi i**de**rstanding specific that their appointment was purely temporary and likely to be terminated at any

time The direct recruitments were made on a temporary basis pending the availability of regular trained staff from the Food Department to man the posts The deputationists from the State Government are experienced in statistical work and cannot be replaced by temporary hands

SHRI K CHANDRASEKHARAN May I know from the hon Minister whether he is aware that so far as the Kerala Regional Office of the Food Corporation of India is concerned it has been turned into a paradise for deputationists and that more deputationists are only wanting to go there because of the increase in emoluments that they get and that during the past one and a half years when there have been direct recruitment direct recruits are being taken, and then after two or three months they are discharged, and in the meanwhile that deputationists arrive, so that the entire work of the Kerala Regional Office has suffered on account of the fact that temporary personnel for two or three months are taken in and then discharged? This is the pattern that has developed in the Kerala Regional Office

SHRI ANNASAHEB SHINDE Madam, I do not know what the hon Member means when he says that it 1s a paradise for deputationists Corporation is supposed to Food undertake the functions which were being carried out by the Food Department previously and it acts as an agent of the State Government in the States Naturally the functionaries who were serving in the Food Department were supposed to be transferred to the Food There is the union of Corporation Government employees There had been pressure from hon Members that statutory protection should be given to them, that they should be transferred to the Food Corporation and necessary protection should be given to them I do not know why there has been some misunderstanding on the part of the hon Member As far as this case is concerned, as I have already explained, these persons were employed

on the specific understanding that their employment would be temporary. The posts which are vacant are tech-Even in regard to the nical posts. general approach to this problem, we have issued instructions recently to the FCI that they should not make direct recruitment and that, anv possible, they should as far as the Food from officers absorb Henceforth ıtself Department would there do not think any more direct recruitment, unless they are of a highly technical nature. Without the permission of the Government no direct recruitment will be allowed.

SHRIMATI C. AMMANNA RAJA: Is it a fact that, when officers from some other departments are sent as deputationists to the Food Department, their emoluments are very much higher? Way should it be so? Why should we give them such attractive salaries? Is it not the poor who have to pay for it? Is it necessary? After all, they are Government servants.

SHINDE: ANNASAHEB SHRT There was a demand on behalf of the Department employees that their interests should be properly looked after. Some attractive emoluments have been provided for them, so that there may not be difficulties in regard to future employment, etc. Even when it has been provided, there are complaints. The hon. Member knows that there is the Government employees' union and they want that the interests of the Food Department employees, who been serving for some years, should be protected and that should be given remunerative salaries. I think the salaries which have been fixed are fixed on the basis of merit as well as on the basis of the functions they are supposed to carry out. A team of officers has properly looked into it.

SHRI K. CHANDRASEKHARAN: Is the hon. Minister aware that a Deputy Collector in Kerala is in the scale of Rs. 400-900 only, whereas some of

these deputationists get double that salary?

THE DEPUTY CHAIRMAN: Members have information on this.

ANNASAHEB SHINDE. About the grades of individual officers. etc., if proper notice is given, I will try to give information.
