THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) to (d) The Detailed Project Report for setting up a Unit at Palghat for the manufacture of precision instruments was approved in August, 1966. An industrial licence was granted to M/s. Instrumentation Ltd., Kota in this regard in March, 1967. The Civil Engineering Office established at Palghat are carrying out the detailed survey of the land and preliminary works at plant site. The Kerala Government have initiated action for installing water supply connection to the site from Malampuzha Dam. Action is under way to process the finalisation of tender papers for construction of plant building. The recruitment of the first batch of 17 Engineers has been completed and a Project Administrator has been appointed. Production is expected to commence during 1969-70.
