

AWARDS FOR OUTSTANDING EXPORT PERFORMANCE

1065. SHRI M. C. SHAH: Will the Minister of COMMERCE be pleased to state;

(a) whether there is any proposal under Government's consideration to institute awards to accord public recognition of outstanding export performance both by institutions and individual exporters; and

(b) if so, what are the details thereof?

THE MINISTER OF COMMERCE (SHRI DINESH SINGH): (a) Yes, Sir.

(b) The proposal under consideration is to give a limited number of awards, in the form of shields, for outstanding export effort. A Committee will be set up to make recommendations for awards. Exporters with outstanding export performance as well as other institutions making significant contributions in the field of export promotion will be considered for awards.

RAILWAY HALT IN BIKANER DIVISION

(a) whether it is a fact that a Rail way halt was sanctioned between Loharu and Parvezipur stations in Bikaner Division; and

(b) if so, when was it sanctioned and whether the halt is functioning now?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) Yes.

(b) A contractor-operated train halt was sanctioned in August 1963 but it has not yet started functioning as the name for the train halt is still under correspondence between the Civil authorities and the Survey of India. The matter is being pursued further by the Railway authorities to have it finalised as early as possible.
