

(c) Seven mills (those marked with asterisks in the statement in para 1 above) closed down only in June and July, 1967 and the question whether any investigation, etc., is necessary in their cases is under consideration, in consultation with the authorities concerned. An investigation Committee has been already appointed under the Industries (Development & Regulation) Act, 1951, to look into the affairs of the Baroda Spinning & Weaving Mills Co. Ltd., Baroda, and further action will be taken on receipt of the investigation committee's report. The cases of four mills viz. Ananta Mills Ltd., Ahmedabad, (2) The Rajaratna Naranbhai Mills Co. Ltd., Petlad, (3) Savatram Ramprasad Mill, Co. Ltd., Akola, and (4) General Fibre Dealers Ltd., Lucknow, are pending in High Courts concerned with regard to their liquidation, etc. As regards the remaining mills, efforts are being made by their managements and the State Governments concerned to restart them.

#### FACILITIES TO THE GROWERS FOR SALE OF COTTON

(a) the quantity of cotton produced in the country in the years 1960 and 1967; and

(b) whether any ceiling price for cotton is fixed and the facilities that are made available for sale of cotton?

THE MINISTER OF COMMERCE (SHRI DINESH SINGH) : (a) According to the official estimate, 4.7 million bales of cotton was produced during the 1965-66 season (September, 1965-August, 1966). For the 1966-67 season, an official estimate is yet to be published. The trade estimate, however, places the production of cotton in this year at 5.3 million bales.
