REHABILITATION OF DISPLACED PERSONS IN GUR KI MANDI

*537. SHRI KRISHAN KANT:
SHRI M. P. BHARGAVA:

Will the Minister of LABOUR AND REHABILITATION be pleased to state:

(a) whether it is a fact that a loan of Rs. 16.55 lakhs was sanctioned to the Municipal Corporation of Delhi for the development of 8.5 acres of land and construction of 170 tenements in Gur Ki Mandi for the rehabilitation of displaced persons;

(b) what is the progress of the construction of tenements; and

(c) what arrangements are proposed to be made for the rest of the 427 families who were evicted from Gur Ki Mandi and shifted to Karampura, Padamnagar, Bagh Amba and Andha Mughal in May, June and July, 1961?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI L. N. MISHRA): (a) Yes, Sir. The area of land which is being developed by the Corporation is 8.65 acres and not 8.5 acres.

(b) 93 tenements are in advanced stage of construction. The construc-

tion of the remaining 77 tenements will be undertaken as soon as the injunction obtained from the Court by the ex-owners of land, where they are to be constructed, is vacated.

(c) After accommodating 170 families in the tenements already under construction or proposed to be constructed in Gur-Ki-Mandi, the rest were to be settled in the area proposed to be developed in Dhaka village and Nimbri village.
