THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE. COMMUNITY DEVE-AND LOPMENT CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) Yes, Sir. In the Conference, it was suggested by some Chief Ministers that subsidy on foodgrains prices could be withdrawn or reduced.

- (b) The Central Government issue prices will go up if the subsidy is withdrawn. These prices are at present much lower than the open market prices of these grains. The increase in the Government issue prices in case of withdrawal of subsidy is not likely to have any appreciable effect on the market prices.
- (c) The estimated subsidy on the distribution of foodgrains during the financial year 1967-68 is Rs. 119 proportionate crores. Α amount would be saved depending on when the subsidy is withdrawn during the financial year.
- (d) There is at present no proposal to withdraw the subsidy on the distribution of foodgrains.

Wrong delivery of baggages by I.A.C.

- 57. SHRI K. CHANDRASEKHAR-AN: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:
- (a) whether any assessment been made of the human errors committed by the ground administration staff of the I.A.C.;
- (b) how many baggages of passengers were sent to wrong destinations during 1966-67 thereby putting the passengers to great inconvenience;
- (c) what steps are being taken to avoid instances of negligence on the part of the Indian Airlines Corporation staff?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Yes, Sir. The I. A. C. have taken into account from time to

time the complaints received on this account.

- (b) 27 cases were reported in 1966-
- (c) An improved type of baggage label with strong cord attachment and the destination station, distinctively printed, is being introduced shortly.

Greater stress is also being laid on the proper segregation and loading of baggage in aircraft.
