As regards communications, both Burma and India are members of the Universal Postal Union, and exchange of correspondence is regulated by the provisions of the Universal Postal Convention. While there are no formal agreements with Burma in respect of customs, cultural relations, immigration or repatriation and of double nationality, the few problems that arise in these fields are handled in a spirit of friendly co-operation.

**U. S. PRESIDENT'S SPECIAL ENVOY'S
VISIT TO INDIA**

(a) whether Mr. Raymond Hare, U.S. President's special envoy, had talks with the Prime Minister, External Affairs Minister and some Government officials;

(b) if so, whether he requested the Government of India to act as a channel of communication between Washington and Cairo; and

(c) what has been Government's reaction thereto?

ISRAEL-UAR DISPUTE

(a) what is the position in regard to the Israel-U.A.R. dispute;

(b) what action, if any, is being proposed to be taken by India to settle this dispute?

(SHRI SURENDRA PAL SINGH):**

(a) At the Emergency Session of the United Nations General Assembly on the West Asian crisis neither the non-aligned resolution nor the Latin American resolution succeeded in getting the required two-thirds majority. Deliberations are still continuing at the United Nations for resolving the West Asian crisis.

(b) India intends to continue her energetic efforts, both inside and outside the United Nations, in order to arrive at a satisfactory resolution of the West Asian crisis which will ensure withdrawals by Israeli forces to the lines occupied by them prior to June 5th, 1967, since this is the first prerequisite for achieving normalcy in this region.
