There was, however, no disruption in unloading apart from the operational difficulties caused due to the monsoons. A number of steps were taken to ensure that grain-handling was increased *as far as possible including, increased berthing and discharge facilities, greater overside and mid-stream discharge of grain and maximum use of ports where foodgrain vessels could be handled even during the monsoons. No difficulty is anticipated in handling the quantities likely to be received in August. A Statement is laid Table of the Sabha showing the on the week-wise arrivals of food expected shipments at each of the ports during the month of August, 1967. [See Appendix LXI, Annexure No. 4]. Such information about the arrivals during the month of September, 1967 is not fully available as yet.
