U.S. LOAN TO AN INDIAN FIEM

*625. SHRIMATI LALITHA (RAJA-GOPALAN): Will the Minister of FINANCE be pleased to state whether it is a fact that a rupee loan of Rs. 1.64 crores is likely to be granted by the United States of America to a new firm in Faridabad, and if so, what are the details thereof?

THE DEPUTY PRIME MINISTER AND MINISTER OF FINANCE (SHRI MORARJI R. DESAI): The U. S. Govt, has agreed to give a loan of Rs. 1.64 crores from PL 480 (Cooley) funds to M/s Blobe United Engineering and Foundry Company Ltd., New Delhi for financing the purchase of indigenously available machinery and plant for their Rolls Project at Faridabad.

PUNJAB GOVERNMENT'S REQUEST FOR FINANCIAL ASSISTANCE

*626. SHRI BHUPINDER SINGH: Will the Minister of FINANCE be pleased to state:

- (a) whether the Government of Punjab have requested the Government of India to reconsider the nature of financial assistance proposed to be given to Punjab for the Fourth Five-Year Plan; and
- (b) if so, what is the reaction of the Government thereto?

THE MINISTER OF STATE IN THE MINISRY OF FINANCE (SHRI K. C. PANT): (a) and (b) The Fourth Five-Year Plan and the financial assistance proposed to be g^ven to the various States for the Fourth Five-Year Plan have not yet been finalised. However, an amount of Rs. 95 crores had been tentatively allocated to the Punjab State for the Fourth Plan. The Government of Punjab had requested the Planning Commission for an increase in this amount, to the extent of Rs. 17 crores. This request was not accepted as the

total amount of assistance as provisionally worked out had already been distributed among the States.
