#### **SOUND AND LIGHT PROGRAMME AT RED FORT**

43. SHRI A. P. CHATTERJEE: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state whether the script of sound-and-light (Son-et-lumiere) programme projected at the Delhi Red Fort is approved by his Ministry?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): Yes, Madam. The script of the 'Son-et-Lumiere' spectacle was approved by the then Ministry of Transport in consultation with the Historical Division of the Ministry of External Affairs.

#### **Are SERVICES BETWEEN JAMMU AND SRINAGAR**

44. SHRI GULAM NABI UNTOO: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) whether it is a fact that Jammu airport is not sufficiently equipped to enable the Viscount to land;

(b) whether the Dakota and Fokker-friendship are unable to gain the height required in cloudy weather to cross the Banihal; and

(c) if the answers to part (a) and (b) above be in the affirmative what

steps Government propose to take to facilitate the air services between Jammu and Srinagar?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH): (a) Yes, Madam.

(b) No, Madam, Dakotas and Fokker Friendships are capable of gaining sufficient height in cloudy weather to cross the Banihal. The main difficulty is in the Dakota not being pressurised and as such it is not possible to climb above 10,500 feet for unpressurised ft/ing. Fokker Friendships are pressurised and there is no difficulty about clearing the Banihal in the event of bad weather.

(c) The aerodrome at Jammu is owned and maintained by the Indian Air Force. The feasibility of developing the aerodrome for operating Viscount type of aircraft is being examined in consultation with the Ministry of Defence.
