(a) and (b) It is not possible to give figures of tourists who were attracted specifically because of the International Tourist Week celebrations in March 1967. Furthermore, it is too early to judge the impact of these celebrations on the tourist arrivals in this country. The various facilities, concessions and other activities which are being observed as part of the, International Tourist Year are likely to show their results by the end of 1967, when it may be possible to compare the tourist arrivals with those of last year.

AIR SERVICE FROM DELHI TO KANAHA NATIONAL PARK, MANDLA

The airstrip near Kanaha is maintained by the State Government and not by the Civil Aviation Department. The suitability of the airstrip for scheduled services is being investigated on the results of which the question of operating a service to Kanaha will be further examined by
