SUPPLY OF GRAINS TO FREE KITCHENS IN SCARCITY AREAS

## 32. SHRI RAM SAHAI: SHRI V. M. CHORDIA:

Will the Minister of FOOD AND AGRICULTURE be pleased to lay a statement indicating the demands made by various State Governments in respect of allotment of grains to be supplied to free kitchens to feed the disabled and destitutes residing in the scarcity areas; and the quantity of grains allotted to each State Government for this purpose?

THE MINISTER OF STATE THE MINISTRY OF FOOD. AGRICULTURE COMMUNITY DE-VELOPMENT AND COOPERATION ANNASAHEB SHINDE): Free kitchens are being run by a number of voluntary organisations in various States. Foodgrains for running these free kitchens are mostly arranged by the voluntary organisations themselves. In some cases, they have asked for some quantities of foodgrains for running these The Ministry of Food and Agriculture have released foodgrains on economic prices to the voluntary organizations as indicated below:
