THE MINISTER OF RAILWAYS (.SHRI C. M. POONACHA): (a) Ye₃. The agreement is for the purchase of components for the manufacture of Metre Gauge Diesel Locomotives not available within the country and will be financed from a non-project loan granted by the Government of Canada.

- Ob) The value of the components to be purchased is of the order of C.\$. 2.2 million equivalent to Rs. 1.52 crores.
- (c) The shipment of the components is expected to commence in about six months.

- (a) the number of posts of Members, Additional Members, Directors etc. carrying Rs. 2000 and above, created on ad-hoc basis in 1966:
- (b) whether it is proposed to give up come more posts; and
- (c) whether the workload had decreased or the surrendered posts were superfluous?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) One temporary post of Economic Adviser in the scale Rs. 1800-2250 was created in 1966.

- (b) It has been decided to give up 6 more posts of Deputy Directors/ Assistant Directors etc. and 14 posts of Section Officers.
- (c) The decision to give up the posts was taken as the result of a review undertaken for the purpose of effecting economy in the administrative expenditure and to streamline the administration. Sanction to two posts of Joint Directors, however, expired on the completion of the specific work for which they were created.

ISSUE OF LICENCES FOR INDUSTRIES IN RAJASTHAN

- (a) the number of licences issued during the last five years for setting up industries in Rajasthan;
- (b) the names of the parties to whom the licences were issued, the particulars of industries and their location;
- (c) the number of industries which have been set up against those licen ces; and
- (d) what steps Government pose to take against those who have taken licences but have not set up the industries so far?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND **COMPANY** AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) Besides expansion granted to existing undertakings,

thirty-six licences were issued during the last five years i.e., 1962-63 to 1966-67, for setting up new industries in Rajasthan.

- (b) A statement, showing the names of the parties to whom the licences were issued the particulars of in dustries, and their location, is atta ched.
- (c) Out of the thirty-six licences, twelve have already 'been revoked or surrendered by the licensees, as they failed to take "effective steps" towards implementation of the licences. The

information relating to the progress made upto-date on the setting up of units against the remaining twenty-four licences, is being collected and wil] be laid on the Table of the House.

(d) Progress in the implementation of licences is periodically reviewed by the Government, and, cases where the Government is satisfied that the licensees have, without reasonable cause, failed to implement the licences or to take "effective steps" within the time stipulated, action is taken to revoke the licences issued to them.
