

संसद्-कार्य तथा संचार विभागों में राज्य-मंत्री (श्री आई० के० गुजराल) : (क) जी हाँ। जाली मनी-आर्डर बनाने और उनकी अदायगी करने के सम्बन्ध में 2 जून, 1967 को पुलिस ने एक व्यक्ति को गिरफ्तार किया है।

(ख) अभी तक जाली मनी-आर्डरों के 23 मामलों का पता चला है।

(ग) जैसा कि पहले ही बताया जा चुका है, कथित अपराधियों में से एक गिरफ्तार कर लिया गया है। पुलिस की तहकीकात जारी है।

(घ) ऐसे मामले फिर से न हों इसके लिये यदि कोई नये उपाय लिये जायेंगे तो वे पुलिस की जांच का परिणाम पता लगाने पर ही किये जायेंगे।

[THE MINISTER OF STATE IN THE DEPARTMENTS OF PARLIAMENTARY AFFAIRS AND COMMUNICATIONS (SHRI I. K. GUJRAL) : (a) Yes. Sir. One person has been arrested on 2-6-1967 by the police in connection with preparation and payment of bogus money orders.

(b) 23 cases of bogus money orders have come to light so far.

(c) As already stated, one of the alleged culprits has been arrested. The police investigation is in progress.

(d) New measures, if any, to prevent the recurrence of such cases, will be taken after the result of police enquiries is known.]

U.G.C. AID TO JODHPUR UNIVERSITY

(a) how much aid has been given by the University Grants Commission to the University of Jodhpur since its inception;

THE MINISTER OF EDUCATION (DR. TRIGUNA SEN): (a) Rs. 26.35 lakhs.

(b) and (c) A statement is laid on the Table of the Sabha.

STATEMENT

(b) and (c) The University of Jodhpur has submitted to the University Grants Commission for assistance proposals involved an outlay of Rs. 306.62 lakhs during the Fourth Plan period. These have been examined by a Visiting Committee set up by the Commission. The report of the Committee will be considered by the Commission in July, 1967. The allocation of grants to the University will be made in the light of the recommendations of the Committee and the availability of funds with the Commission.

In addition, another proposal of the University for reimbursement of expenditure incurred on the purchase of books and journals for Humanities and Social Sciences during the Third Plan period over and above the grant already paid to the University is under the consideration of the Commission. This proposal is also linked with the allocation of grants to the University in the Fourth Plan.
