- 100. SHEIMATI DEVAKI GOPI-DAS: Will the Minister of WORKS, HOUSING AND SUPPLY be pleased to state:
- (a) what is the expenditure incurred for the construction of new flats for the Members of Parliament in North Avenue, New Delhi:
- (b) whether Government have received complaints about the bad, defective and substandard construction of those flats; and
- (c) if so, what additional expenditure has been incurred by the Government for reconstructing the floor and mending the other defects by this time?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH): (a) Rs. 4.50 lakhs.

(b) and (c) Complaints of minor defects, such as reverse slopes in bathrooms, cracks in walls, etc., had been received. Some of the defects were rectified by the contractors themselves and the remaining defects are being rectified at their cost. No substandard material has been used in the construction of these flats.

- (d) The total length of aditing required for the project i_s 16000 metres and the aditing so far done i_s 1600 metres by working manually. The progress would be accelerated as soon as key mining machinery which is expected by the middle of the current year is received.
