Since then the Undertaking have, in addition to 50 buses hired from private operators, added 38 of their own buses including 2 double deckers to the fleet. The target of 950 buses is likely to be achieved by the end of April, 1967.] LAUNCHING

METEOROLOGICAL ROCKET STATION IN NORTH-WEST INDIA
