**STATEMENT RE OFFER OF FOOD
AID BY CANADA**

THE MINISTER OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT AND CO-OPERATION (SHRI C. SUBRAMANIAM): Sir, I am happy to inform the House that the Government of Canada have announced their intention to offer food aid to the Government of India of \$ 21 million during the current Canadian fiscal year ending 31st March 1967 and further aid of \$ 50 million during the next fiscal year beginning 1st April, 1967. The provision of these funds would enable the supply of about 900,000 tonnes of Canadian wheat and would be of very great help to us in meeting the difficult food situation.
