THE MINISTER OF INFORMA-TION AND BROADCASTING (SHRI K. K. SHAH): (a) and (b) Soviet Embassy had tendered no advice to the Government of India in respect of the film "Dr. Zhivago" in India, but had drawn our attention to the fact that the exhibition of the film "Dr. Zhivago" would be embarrassing to the Soviet Union. very careful consideration of the matter Government decided to pass the picture with such cuts as were considered necessary keeping in view the susceptibilities of a friendly country.

A Farm and Home Unit at Sangli is now proposed to be set up during the Fourth Five Year Plan.
