THE MINISTER OF PLANNING, PETROLEUM AND CHEMICALS AND SOCIAL WELFARE (SHRI ASOKA MEHTA): (a) and (b) Government of Gujarat had proposed some financial provision for the Narmada project at Navagam in their Fourth Plan proposals. During discussions between the Planning Commission and the State Government, tentative conclusions were reached as to the overall allocation for the Major and Medium Irrigation programmes in the State. The scheme-wise details of this a'location have not yet

been furnished by the State Government and it is not therefore possible to say what amount they propose to spend on the Navagam project.
