MODEL SYLLABUS FOR B. COM.

296. SHRI SITARAM JAIPURIA: Will the Minister of EDUCATION be pleased to state:

- (a) whether it is a fact that an All India model syllabus for B. Com. has been prepared and sent to various universities for implementation;
- (b) if so, how many universities have implemented it and how many of them have refused to do so;
- (c) whether any Central University has accepted and implemented the syllabus; and
- (d) if not, the reasons therefor and the action Government propose to take in this regard?

THE MINISTER OF EDUCATION (DR. TRIGUNA SEN): (a) Yes, Sir.

(b) to (d) The Scheme formulated by the All India Council for Technical Education serves only as a model and a guide and lays down the minimum standards. It is not the intention of the All India Council for Technical Education that the scheme should be adopted by all the universities in toto as formulated. Except in so far as a certain acceptable minimum standard would enable mutual recognition for purposes of advanced courses and assist in recruitment, there is no need for all universities to have an exactly identical course and hence no information has been collected.
