DISPLACED FAMILIES IN JAMNAGAR

269. SHRI JAIRAMDAS DAULATRAM: Will the Minister of LABOUR AND REHABILITATION be pleased to state:

(a) the number of displaced families living in the houses in Deltas in Jamnagar in Gujarat and the number of years they have been living there;

(b) whether these Deltas were used as stables before partition and as houses for wrestlers by the former ruler of Jamnagar;

(c) whether it is a fact that Government have asked these displaced families to pay rent for several years though their daily earnings are very low and inadequate owing to the prevailing high prices;

(d) whether there is proper drainage, lighting and toilet arrangements in these Deltas; and

(e) what are Government's plans for better housing of these displaced families?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI L. N. MISHRA): (a) to (e) Houses in Deltas at Jamnagar 380RSD—3.

in Gujarat State are not the properties of Central Government and it is not known whether any displaced families are living in them. However, requisite information has been called from the State Government and will be laid on the Table of the Sabha.

SINDHI BOOKS IN NATIONAL LIBRARY, CALCUTTA

270. SHRI JAIRAMDAS DAULATRAM: Will the Minister of EDUCATION be pleased to state the number of titles in Sindhi language in each subject, received by the National Library, Calcutta under the Delivery of Books (Public Libraries) Act, 1954 during each of the years from 1955 to 1965-66?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION (PROF. SHER SINGH): The National Library received about 550 titles in Sindhi language during the period 1955 to 1966. The Library compiles statistics of books only in those languages, in so far as Indian languages are concerned, which are recognised by the Constitution of India. However the subjectwise statistics for Sindhi publications received during the years 1963-66 are as follows:—

COMPLAINTS OF CORRUPTION IN IRON FOUNDRY

271. SHRI BANKA BEHARY DAS: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether the Central Bureau of Investigation have received any complaints of corruption in the functioning of iron foundry situated at Dhanmandal in Orissa;

(b) if so, what are those complaints; and

(c) what action has been taken by the Bureau in the matter?

THE MINISTER OF HOME AFFAIRS (SHRI Y. B. CHAVAN): (a) to (c) No complaint of corruption in the functioning of any iron foundry situated at Dhanmandal in Orissa was received by the Central Bureau of Investigation. However, an information was received by the Central Bureau of Investigation that the Station Master, Dhanmandal in violation of the Railway Rules accepted consignments of iron scrap from an iron foundry at Dhanmandal for despatch by rail. The matter has been taken up for enquiry by the Central Bureau of Investigation and the same is in progress.

COLLIERY WORKERS PROVIDED WITH ARTIFICIAL LIMBS

272. SHRI T. V. ANANDAN: Will the Minister of LABOUR AND REHABILITATION be pleased to state the number of colliery workers who

have been provided with artificial limbs out of the Coal Mines Labour Welfare Fund during 1965 and 1966, and the cost thereof?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI JAISUKHLAL HATHI): Ten colliery workers were provided with artificial limbs during 1965 at a cost of Rs. 4,962 and, twenty two workers, during 1966, at a cost of Rs. 8,362.

THIRD PARTY SETTLEMENT IN LABOUR TROUBLES

273. SHRI A. D. MANI: Will the Minister of LABOUR AND REHABILITATION be pleased to state:

(a) whether Government's attention has been drawn to an observation made by Shri V. V. Giri to the effect that the introduction of the "third party settlement" and compulsory adjudication was responsible for many of the troubles that India witnessed at the present time;

(b) whether Government propose to implement the suggestion that there should be a joint standing machinery in every industry with equal representation for the workers and the employers; and

(c) whether any such proposal has been made by any organised body of labour to Government?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI JAISUKHLAL HATHI): (a) to (c) Shri Giri's views on the subject are
