THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE COMMUNITY DEVE-LOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) In pursuance of the Supplementary Agreement to the Indo-Swedish Fin-Cooperative encial Development Agreement an Indo-Swedish Study Team was appointed to recommend an grain-storage system for efficient India with particular reference to major ports. A firm of Swedish Consultants was also subsequently appointed to prepare project reports and engineering designs for the proposed projects. Negotiations for eid to cover the foreign exchange requirements for setting up the silos will be taken up if and when these projects are approved by the Government.

(b) The Indo-Swedish Team recommended construction of silos and installation of bulk-handling equipment at Kandla, Madras, Haldia and Bombay. The cost of the 4 projects, according to preliminary estimates, is likely to be Rs. 8:80 crores. The report of the Study Team is under consideration of the Government.

CLOSURE OF SUGAR MILLS IN WEST U.P.
