- (b) These piece rated workers demanded payment at monthly rate of pay in the authorised scales.
- (c) These workers are not eligible for authorised scales of pay. When the position was explained to them they demanded higher rates and wanted that the method of payment should be on a wagon-rate basis instead of on a weight-rate basis.
- (d) The demand for payment on a wagon-rate basis has been accepted and the rate revised from 8th February, 1967.

BLACK-MARKETING IN THIRD ctAM SLEEPING ACCOMMODATION

- 56. SHRI MAHAMMED HANEEF: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government's attention has been drawn to the increasing rate of black-marketing in reserved III class sleeping accommodation; and
- (b) if so, whether Government are considering any proposal of increasing the number of III class sleeping coaches?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) A few complaints regarding Mack-marketing in third class sleeper accommodation have been received.

(b) Approximately 1000 third class sleeper coaches are already running on Indian Railways. Further, it is proposed to build about 1000 more third class sleeper coaches during the Fourth Plan period for introduction on trains involving night journeys.
