in Delhi while that in Ahmedabad and Calcutta is expected to start next month. These three units will also go into production during 1967-68.

4. The bakeries to be established with Canadian assistance will be set up at Chandigarh, Hyderabad and Kanpur. Developed pieces of land in the industrial areas in Chandigarh and Hyderabad have already been selected while for Kanpur an offer has been received from U.P. Government. It is too early to say about the completion of these units.

SHRI BABUBHAI M. CHINAI: In view of the fact that it has been mentioned in the Statement that six units are coming from Australia under the Colombo Plan, and three are from Canada, may I know as to whether these units will be run on no-profit-no-loss basis or whether any will be subsidised if it is found to be running on loss basis, or whether they will be running on profit basis?

SHRI ANNASAHIB SHINDE: All these units will be run on a commercial basis, and Modern Bakeries (India) Ltd. is a public sector undertaking and it has been registered. It will be presided over by the Food Secretary. There is no question of giving any subsidy to these undertakings.

SHRI BABUBHAI M. CHINAI: Since the hon. Minister has stated that a limited concern has been floated for this purpose, may I know what is the authorised capital and what is the paid-up capital of this concern?

SHRI ANNASAHEB SHINDE: The authorised capital is to the tune of one crore of rupees.

SHRI ARJUN ARORA: Sir, the original intention of the Government, as declared on the floor of this House, was that the Food Corporation of India should take it up. Then why for such small purposes as having four bakeries has the Government decided to tet up a new corporation, which will

obviously involve extraordinarily large overhead expenditure? Why could not the Food Corporation of India do this, as was the original intention?

SHRI ANNASAHIB SHINDE: This was examined. It was found to be more in the national interest to have an independent concern floated like this. That was the conclusion of the experts.

SHRI ARJUN ARORA: Who were the experts? In this country there are hardly any bakery experts. That is what the concerned Ministry of the Government felt last year and so they went in for American collaboration.

MR. CHAIRMAN: More or less experts.

SHRI ANNASAHEB SHINDE: I am not prepared to accept that we have no experts here. We have intelligent people in our country.

SHRI NIREN GHOSH: May I know whether the Minister is aware that the fleet of buses is less than what is needed to cater to the needs of the public? The public have to stand for half an hour in a queue to catch a bus. So will the Government consider increasing the number of buses under the D.T.U.?

PROF. V. K. R. V. RAO: Sir, the Government have considered this. As a matter of fact there is a big programme under the Fourth Plan for increasing the number of buses. We have already made a contract with the Delhi Bus Contractors' Association for hiring private buses and about 40 to 60 private buses are being run in addition to the fleet of buses under the D.T.U.

SHRI LOKANATH MISRA: Do your have a Fourth Plan now?

(No reply)

PROF. V. K. R. V. RAO: I do not understand this question, Sir. As a matter of fact, what I have read from the files is that private bus owners are not anxious to run, buses although they are being paid 70 paise per kilometre. In fact by 31-12-66 they had withdrawn from the whole programme and then further orders were issued by Government raising the rate to 90 paise per kilometre and raising the minimum guaranteed mileage 112 kilometres to 150 kilometres. Even then they suspended the gramme and we had only some buses on the road by the middle March. By the end of March we were to have 100 buses and so far as my latest information goes only some 50 to 60 buses are now available. Therefore, I believe all this question somebody paying somebody for plying private buses is, I am afraid, rather far-fetched.
