SUPPLY OF IMPORTED WHEAT TO PUNJAR

*116. SHRI NARINDAR SINGH BRAR: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

- (a) the quantity of imported wheat supplied to Punjab during the last six months:
- (b) the quantity of imported wheat demanded by the Government of Punjab during the above period; and
- (c) the quantity of indigenous wheat procured by the Punjab Government and taken by the Central Government during the above period?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) About 110,000 tonnes during September, 1966 to February, 1967.

- (b) Various demands for imported wheat had been received from the Punjab Government from time to time. These were examined in consultation with the State Government and monthly allocations to Punjab were given on the basis of availability with the Centre and the relative needs of Punjab and other deficit States.
- (c) Punjab Government procured only 10,000 tonnes of wheat during this period. They supplied to the

Government of India during this period a little over 12,000 tonnes of indigenous wheat.

IMPORT OF FOODGRAINS

65. SHRI K. C. BAGHEL: SHRI G. R. PATIL.

Will the Minister of FOOD AND AGRICULTURE be pleased to state:

- (a) the quantity and the import prices of foodgrains imported, country-wise, during the last 3 years;
- (b) the prices per quintal charged by the Centre from consumers in the Centrally administered areas; and
- (c) the element of subsidy, if any, per quintal?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) The required information for the years 1963-64 to 1965-66 is given in the enclosed statement (Statement I). [See Appendix LIX, Annexure No. 3].

- (b) Foodgrains are not issued direct to consumers from Central stocks in the Centrally administered areas. These are issued to the concerned Administration who distribute further to consumers through price shops, ration shops, etc. statement (Statement II) is. ever, attached indicating the issue price of foodgrains to various Centrally administered areas. [See Appendix LIX. Annexure No. 4].
- (c) A statement (Statement III) giving the required information is attached. [See Appendix LIX, nexure No. 5].

IMPORT OF MANURE

66. SHRI K. C. BAGHEL: Will the Minister of FOOD AND AGRICUL-TURE be pleased to state:

- (a) whether it is a fact that a large quantity of manure was imported during the last three years;
- (b) if so, the quantity of manure imported (country-wise and yearwise); and
- (c) the total amount of foreign exchange involved therein?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRI-CULTURE, COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI ANNASAHEB SHINDE): (a) Presumably the reference is to import. of bulky organic manures. Imports of such manures are not being made, as these are indigenously produced.

(b) and (c) Do not arise.
