(c) whether there is any scheme to provide fans in the servant quarters of Members of Parliament this year; if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH): (a) 6,480 Class IV employees' quarters have been provided with fans and V.656 quarters are still to be so provided.

(b) Rs. 9,14,541.

(c) No. The question of providing fans at Government expense in quarters of the private servants of Members of Parliament has not been considered.

#### 2-ROOMED QUARTERS TOR CLASS IV EMPLOYEES

116. SHRI D. THENGARI: Will the Minister of WORKS, HOUSING AND SUPPLY be pleased to state:

(a) whether, in pursuance of the Government's decision to construct only two-roomed quarters for Class IV employees of the Government of India, there is a scheme under Government's consideration for the construction of such quarters in Delhi/ New Delhi this year; and

(b) if so, the number of such quarters to be constructed and at what cost?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS, HOUSING AND SUPPLY (SARDAR IQBAL SINGH): (a) and (b) Subject to availability of funds, it is proposed to construct about 1200 two-roomed quarters for Class IV Central Government employees in New Delhi at a cost of about Rs. 112 lakhs, during the next financial year.

#### INCENTIVE TO THE BLIND IN DELHI

(a) whether any incentive is proposed to be given to the able-bodied blind-men in the Union Territory of Delhi who want to start some music-teaching school or some such kind of work to earn their livelihood; and

(b) if so, the manner in which Government propose to help such persons?

THE MINISTER OF STATE IN THE DEPARTMENT OF SOCIAL WELFARE (DR. SHRIMATI PHUL-RENU GUHA): (a) At present the Delhi Administration has no scheme for this purpose.
