The shortfall is 2.1 million kgs.

- (c) 'In 1966 U.K. imported about 234 million kgs. of tea as against 254 million kilograms in 1965. Her purchases from the African countries in 1966 were also higher than those in 1965. Consequently there is a fall in the \*hare of India in the U.K. market.
