- *187. SHRI G. R. PATIL: Will the Minister of COMMERCE be pleased to refer to the answer given to Starred Quation No. 625 in the Rajya Sabha on 8th December, 1966 state:

- (b) whether there has been shortfall in export of tea to country; and

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI M. SHAFI QURESHI): (a) and (b) During the first eleven months οf 1966-67, India's exports of tea U.K. stand tentatively at 96.3 million kilograms as against her export of 98.4 million kilograms during the corresponding period of 1965-66. shortfall is 2.1 million kgs.

(c) In 1966 U.K. imported about 234 million kgs. of tea as against 254 million kilograms in 1965. Her purchases from the African countries in 1966 were also higher than those in 1965. Consequently there is a fall in the share of India in the U.K. market.
