whether they have been actually used on a major scale, and, if so, whether their forecast has been found to be correct?

SHRI BHAGWAT JHA AZAD: Sir, the Institute has made in the first batch 5 of them and 3 are being used by the Institute 1 in the Benaras Hindu University and the other has been given to the Government of Mysore. In the second batch the Institute proposes to make 20 of them. So far as the forecast is concerned, these forecasts are based on scientific information and data and as far as they ^.have been experimented with, we find that they give good information.

SHRI M. C. SHAH: What is the capacity of these meters? Up to what depth do these meters find out underground water resources?

SHRI BHAGWAT JHA AZAD: They can do it up to 250 metres under favourable conditions and give us information.

SHRI DALPAT SINGH: From which country ar these meters imported and how much foreign exchange have we to pay for them?

SHRI BHAGWAT JHA AZAD: Sir, they are made in this country and they are 100 per cent indigenous. The cost is about Rs. 3,000. Only 1 per cent of the raw material which comes to about Rs. 30 is imported from outside, even less than Rs. 30.

•201. SHRI M. P. BHARGAVA: Will the Minister of EDUCATION be Dleased to state whether it is a fact that a student of the Indian School of International Studies has been asked to sever his connection with the School on the question of submitting his thesis in Hindi?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION BHAGWAT JHA AZAD): No. Sir.

SHRI M. P. BHARGAVA: May J know from the hon. Minister whether it i<sub>3</sub> a fact that the gentleman in question was not permitted to appear in the pre-thesis examination in Hindi and was asked to leave the Institute?

SHRI BHAGWAT JHA AZAD: Sir, this school offers a three-year course leading to the Ph.D. Degree. In the first year there are certain compulsory courses. The gentleman whom the hon. Member mentioned, Shri Ved Pratap Vaidik, was a student in the Institute who answered his four papers in the first year in Hindi. The Academic Council said that the medium of the school is English and the examination medium is English and therefore, he is deemed to have not sat in that examination and he was removed from the school.

Venkata Ra-mani, the Head of American Studies, is the Chief Organiser and confident supporter of American interests, and in that capacity he travels to the U.S.

May J know whether a proper investigation will be made into the affairs of this institute in order f cleanse it of CIA and other agents who, in the name of autonomy, ar-s digging into the institute and distort its development and growth and give it a particular orientation in the direction of US policies?

DR. TRIGUNA SEN: I wish he gives me the names, so that I can enquire. Surely if he gives me tne names, I will enquire into it.
