THE MINISTER OF EDUCATION (DR. TRIGUNA SEN): (a) and (b) The National Council of Educational Research and Training has undertaken a big programme of text-books for all stages of school education. textbooks produced under programme are offered to the States for adoption or adaptation.

For colleges and universities, American and British tex-goods and standard works are being republished in low-priced editions in cooperation with those countries.

SECURITY ARRANGEMENTS IN DELHI FOR VISITING CHIEF MINISTERS
