†[Demotions and Abolition of Posts in Railway Board

127. SHRI RAJNARAIN: SHRI V. V. RAMASWAMY:

Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that the officers of the Railway Board have expressed dissatisfaction and opposition to the policy of demotions as a result of the deficit budget of the Railways;
- (b) whether 51 posts of Joint Directors were abolished but a new post of Assistant Director for Ticket Checking was created in the Railway Board; and
  - (c) if so, the reasons therefor?]

रेल मंत्री (श्री: सी० एम० पुनाचा): (क) रेलवे बोर्ड ने इस तरह पदावनत करने की कोई नीति नहीं अपनायी है। इसलिए

इस तरह की नीति के प्रति ग्रसन्तोष या विरोध प्रकट करने का प्रक्न नहीं उठता।

(ख) और (ग). रेलों में विभिन्न स्तरों पर प्रशासन को गतिशील बनाने ग्रीर प्रशासन-व्यय में किफायत बरतने के उद्देश्य से विभिन्न पदों के कार्य-भार ग्रौर ग्रौचित्य की जांच की गयी है। इस सिलसिले में रेलवे बोर्ड के कार्यालय में संयुक्त निदेशकों के पद 6 समाप्त कर दिये गये हैं, लेकिन इन पदों पर काम करने वाले अधिकारियों को उसी ग्रेड में उपयुक्त पदों पर लगा दिया गया हैं। प्राक्कलन समिति की सिफारिश के श्रनुसार रेलों के विभिन्न खण्डों पर बिना टिकट यात्रा का ग्रन्दाजा लगाने के लिए ग्रगस्त, 1966 से सहायक निदेशक (टिकट जांच) का एक कनिष्ठ पद बनाया गया है। बिना टिकट यात्रा को वाम करने के लिए उपाय निकालने के उद्देश्य से समय समय पर इस तरह की ममीक्षा की जाती है।

†[THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) There has been no policy of demotions, as such, adopted by the Railway Board and therefore, the question of expression of dissatisfaction and oppositon to such a policy does not arise.

(b) and (c). In order to streamline the administration at various levels on the Railways and to effect economy in administrative expenditure, a 1eview of workload of and justification for various posts has been undertaken. In this connection, 6 posts of Joint Directors have been given up in the Railway Board's Office but the incumbents of these posts have been suitably provided for in the same grade. A junior post of Asstt. Director, Ticket Checking, was created in August, 1966 for making an assessment of the extent of ticketless travel on different sections of the Railways as recommended by the Estimates Committee. Such reviews are undertaken periodically in order to devise measures for reducing the incidence of ticketless travel.

## PRODUCTION OF DRY BATTERY CELLS

128. SHRI V. M. CHORDIA: Will the Minister of INDUSTRIAL DE-VELOPMENT AND COMPANY AF-FAIRS be pleased to state:

- (a) what is the estimated consumption of dry batteries in India;
  - (b) what is the present production;
- (c) the number of companies which have been licensed to produce dry batteries cells;
- (d) what is their production against the target of production for which these have been licensed; and
- (e) what steps are being taken by Government to increase production?

THE MINISTER OF INDUSTRIAL DEVELOPMENT AND COMPANY AFFAIRS (SHRI FAKHRUDDIN ALI AHMED): (a) to (e) There are 5 units which hold licences under the Industries (Development and Regulation) Act, 1951 for manufacture of dry cells and two more units have letters of intent. been given total licensed capacity is 481.5 million number per annum and the letters of intent have been issued for a capacity of 105 million numbers per annum. The production during the last 2 years was as follows:

 293.31 million numbers

 1966-67
 358.82 million numbers

During the year 1965-66, 28 million numbers of cells were exported and during 1966-67 (upto November, 1966) 12 million numbers have been exported. As against the above, production during the year 1966-67 was 358.82 million numbers. Thus the average of indigenous consumption during the past two years has been of the order of 300 million numbers.

2. The production target for Fourth Plan is estimated at 650 million num-
