THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA); (a) Yes, for 36 hours.

- (b) On 6th April 1967, 2 trains were held up at Hooghly Ghat on Naihati-Bandel Section from 08-50 hours and 09-57 hrs. respectively, by about 200 passengers. The demonstrators squatted on the railway track. The police made efforts to pacify the demonstrators, but all in vain, A local M.L.A. and the District Magistrate talked to the quaters at length and they thereafter dispersed and" allowed he trains to move.
- (c) A case has been registered by Government Railway Police, Bandel under Sections 143/341 IPC and 121 of Indian Railways Act. The case is still under police investigation.

Maintenance of law and order in railway premises as also safety and security of railway property and life and property of passengers and railway employees is the responsibility of the State Government and the State Government Railway Police and close co-operation as required is maintained with them at various levels.
