THE MINISTER OF STATE IN THE MINISTRY OF LABOUR, EMPLOYMENT AND REHABILITATION (SHRI L. N. MISHRA): (a) No. Displaced Persons have the option to make initial payment of 20 per cent of the value of the property and the balance in 7 annual instalments i.e. pay the entire dues in 8 years.

- (b) The mode of payment as indicated in reply to part (a) of the question is fixed under Rule 42 of the Displaced Persons (Compensation & Rehabilitation) Rules, 1955, as approved by the Parliament. The extention of period to 30 years is not considered justified.
- (c) The interest is chargeable on delayed payments in accordance with Rule 28 of the Displaced Persons (Compensation & Rehabilitation) Rules, 1955.

ORIGIN OF GYPSIES

159. SHRI JAIRAMDAS DAULAT-RAM: Will the Minister of EDUCA-TION be pleased to refer to the reply to Unstarred Question No. 141 given in the Rajya Sabha on the 31st March, 1967 and state:
