MODIFIED DEVANAGRI SCRIPT

172. SHRI V. V. RAMASWAMY: Will the Minister of EDUCATION be pleased to state whether it is a fact that the Union Education Ministry have evolved a modified Devanagri script incorporating the sounds prevailing in all the regional languages of India?

THE MINISTER OF STATE TN THE MINISTRY OF EDUCATION (PROF. SHER SINGH): In order to facilitate the expression in writing of certain peculiar sounds of other regional languages which are not found inDevanagari, certain diacritical marks to denote these peculiar sounds have been evolved and added to the Devanagri script. Copies of pamphlet issued in this behalf are available in the Parliament Library.

WB-14(1)/64 and WB-14(3)/66, dated the 28th May, 1967 and 27th January, 1967 respectively showing composition and terms of reference of the Wage Board is placed on the Table of the House. The Wage Board is considering the question of interim relief. (See below)

- 3. The following will be terms of reference of the Board:—
 - (a) to determine the categories of employees (manual, clerical, supervisory etc.) who should be brought within the scope of the proposed wage fixation;

(b) to work out a wage structure ! based on the principle of fair wages as set forth in the Report of the Committee on Fair Wages;

Explanation.—In evolving a wage structure, the Board will take into account, in addition to the considerations relating to fair wages:-

- (i) the needs of the industry in a developing economy including the need for maintaining and promoting exports;
- (ii) the requirements of social justice;
- (iii) the need for adjusting wage differentials in such a manner as to provide incentive to workers for advancing their skill;
- (iv) the special features of the road transport industry; and
- (v) the desirability of extending the system of payment by results;

Explanation In applying the sytem of payment by results, the Board shall keep in view the need for fixing a minimum (fall back wage) and also to safeguard against over-work and undue speed.

- 4. The coverage of the Wage Board will be restricted to establishments employing 20 or more workers.
- 5. The headquarters of the Board will be located at Delhi subject to approval of the Accommodation Advisory Committee.
