

stalls, vendors, taxi stands, are being removed from the congested areas.

- (xi) After a systematic study of road accidents in Delhi, 21 "accident prone" locations have been chosen by the Central Road Research Institute. Detailed analysis of the accidents at each of these places has shown that drivers are mainly responsible for most of the accidents. A new accident spot warning sign has been installed at these places to warn road users of the existence of these high "accident frequency" spots.

NATIONAL FOOD COUNCIL
