**DETERIORATION IN THE QUALITY OF LAMBRETTA SCOOTERS**

817. SHRI R. P. KHAITAN: Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that the quality of Lambretta Scooters manufactured recently has much deteriorated;

(b) whether Government have received complaints from the customers about this fact; and

(c) if so, whether Government have taken any action in the matter?

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA): (a) No Sir. Government have not come across any evidence to suggest that the quality of Lambretta scooters has deteriorated recently.

(b) and (c) A few complaints had been received. These have been brought to the notice of the manufacturers by the Directorate General of

Technical Development for remedial action.

**ENGINEERS SENT TO U.S.S.R. BY HEAVY ELECTRICALS, HARDWAR**

818. SHRI BANKA BEHARY DAS: Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that in the case of second batch of engineers of Heavy Electricals, Hardwar, consisting of 63 engineers sent to USSR for training, the fields of specialisation were changed after six to eight months of training and there was consequent loss of the time; and

(b) if so, the reasons for this change?

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA): (a) No, Sir. The field of specialisation was changed in the case of seven trainees only and this was after about four months of their departure from India. There was no loss of time since the Engineers concerned received general theoretical training during the initial period.

(b) The changes were made on the advice of the Russian consultants, on the basis of experience gained, and in view of the specialisations that were required to be covered.

**BOARD FOR ALLOCATION OF DUTIES TO ENGINEERS OF HEAVY ELECTRICALS TRAINED IN U.S.S.R.**

(a) whether any board was constituted by the management of Heavy Electricals for allocating duties to the engineers trained in U.S.S.R.; and
