**THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI M. SHAFI QURESHI):** (a) Five.

(b) For the year October, 1966—September, 1967, an allocation of Rs. 30 lakhs has been made for import of raw wool for the woollen mills in Jammu and Kashmir. The quantity would depend on the qualities and prices of wool imported.

(c) No, Sir. Two of the mills in the State are under the Government of Jammu & Kashmir.
