- \*84. SHRI BANKA BEHARY DAS: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that the World Bank proposes to increase the interest rate on its loan;
  - (b) if so, what is the proposal; and
- (c) whether the Government of India has objected to this increase and has advised the Bank against the rate increase?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI):
(a) and (b) There is no such proposal; the President of the World Bank indicated in his address to the Annual Session of Governors that he expected to re-examine the interest rate on loans to be made by the World Bank.

(c) The Government of India will wait the re-examination (if any) and take appropriate steps to advise the World Bank of its views when the results of the re-examination are made known.
