t[FALL OF PASSENGERS FROM RUNNING TRAINS

159. SHRI NIRANJAN VARMA: Will the Minister of RAILWAYS be pleased to state:

(a) the number of passengers who fell down from running trains between Jhansi and Itarsi, so far from July, 1966 and the number of the persons out of them who were killed;

(b) whether there is a heavy rush in the trains running on the section resulting in these incidents; and

(c) when, a fast train is likely to be introduced in this section?

रेल मंत्रालय में उपमंत्री (श्री शामनाथ):

(क) 1 जुलाई, 1966 से 30 सितम्बर, 1966 की अवधि में झांसी और इटारसी स्टेशनों के बीच चलती गाड़ियों से 8 व्यक्ति गिरे जिनमें से दो की मृत्यु हो गयी ।

(ख) झांसी और इटारसी के बीच चलने वाली कुछ गाड़ियों में अधिक भीड़-भाड़

होती है, लेकिन अधिक भीड़-भाड़ के कारण ही ऐसी घटनाएं होती हैं, यह बात नहीं है।

(ग) चौथी योजना में झांसी-इटारसी खण्ड से गुजरती हुई बम्बई वी० टी० से दिल्ली तक एक एक्सप्रेस गाड़ी चलाने की योजना बनायी गयी है। झांसी में यह गाड़ी दो हिस्सों में बंट जायेगी, एक हिस्सा लखनऊ और दूसरा दिल्ली जायेगा।

†THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAM NATH): (a) During the period 1st July, 1966 to 30th September, 1966, 8 persons fell down from running trains between Jhansi and Itarsi stations of which two were killed.

(b) There is overcrowding in some of the trains running between, Jhansi and Itarsi, but overcrowding does not necessarily cause such incidents.

(c) An Express train from Bombay V.T. to Delhi passing through Jhansi-Itarsi Section has been planned to be introduced during the Fourth Plan period. This train will bifurcate at Jhansi, one portion going to Lucknow and the other to Delhi.]
