- (a) whether it is a fact that Government have recently chalked out certain measures to boost the production of farm implements in order to in rease food production in the country; and
- (b) if so, the details of the measures devised and how they are being implemented?

THE DEPUTY MINISTER IN THE MIN'STRY OF FOOD. AGRICUL-TURE COMMUNITY DEVELOP-MENT AND CO-OPERATION (SHRI S. D. MISRA): (a) Yes.

(b) A statement is attached.

STATEMENT

A number of measures have been suggested and taken to boost production of agricultural implements. Some of the important ones are: ---

- 1. In many of the States. Workshops at regional and district levels have been set up which are manufacturing agricultural implements and selling these to farmers.
- 2. There are a large number of organised industries in private sector manufacturing agricultural implements.
- 3. Manufacturers of agricultural implements have been given Export Incentives as a result of which agricultural imp'ements are also being export-
- 4. The IV Plan Working Group on Agricultural Implements has recommended setting up State Level Workshops and Implement Centres for development and demonstration of agricultural implements. Many of the State Governments arcording their local needs have implemented the recommendation.
- 5. A Centrally Sponsored scheme aiming at supplying the up-

to-date seed-cum-fertiliser drills has been put into operation to increase agricultural production.

- 6. Manufacturers of Agricultural Implements are supplied with latest and up-to-date designs of blue prints of agricultural implements and technical advice.
- 7. A number of refresher courses and other training schemes are in operation for imparting in service training to personnel engaged in agricultural engineering activities to acquaint them with the latest technological developments. Village artisans are being trained in the 39 Workshop wings attached to Gram Sevak Training Centres in manufacture, use and repair of agricultural implements.
- 8. The following Five Firms have started manufacturing tractors:-
 - 1. TAFE Private Ltd., Madras.
 - 2. Tractors and Bulldozers Ltd., Baroda
 - 3. International Tractors Ltd., Bombay.
 - 4. Escorts (Pvt.) Ltd., Farida-
 - 5. Eicher Corporation, Faridabad.

About 6,000 tractors were manufactured during 1965 and there is a likelihood of manufacturing 10,000 tractors this year.

- 9. Power Tillers are also being manufactured by M/s. Krishi Engineers (Pvt.) Ltd., Hyderabad.
- 10. Machines required for seed processing (cleaning, grading, shelling etc.) are now manufactured in India. Paddy threshers required for high yielding varieties of crop such as Tainan-3 variety of paddy have been got manufactured Power threshers of good

quality are now manufactured at Ludhiana and Ahmednagar. These are suitable for wheat and jowar respectively.
