

†[THE MINISTER OF HEALTH AND FAMILY PLANNING (DR. SUSHILA NAYAR): (a) No changes in the procedure of admission of students to the All-India Institute of Medical Sciences, New Delhi have been made this year. A change was, however, made in 1965.

(b) It was felt that the candidates selected for admission to the medical course purely on the basis of University or competitive examinations did not turn out to be the best medical graduates. Keeping this in view the Institute decided to introduce personal assessment of the candidates by holding a personal interview by an Assessment Committee to evaluate such candidates not only on his/her past academic record and standing in the competitive examination but also on his/her motivation, physical fitness, aptitude personality and psychological traits ]

**REDUCTION OF EXPORT DUTY ON COTTON**

(a) whether it is a fact that Government have decided to reduce export duty on certain varieties of raw cotton; and

(b) if so, what are the details of such varieties of cotton and the reasons for taking the decision?

THE MINISTER OF FINANCE (SHRI SACHINDRA CHAUDHURI): (a) Yes, Sir.

(b) With effect from the 14th October, 1966 the export duty on certain varieties of raw cotton has been reduced. Copies of the relevant notifications are annexed. [See Appendix LVIII, Annexure No. 21]. These concessions were granted because it was found that at the then existing rate of export duty, these varieties of cotton
