# \_\_\_ ALLOTMENT OF SCOOTERS

281, SHRI ABDUL GHANI: Will the Minister of INDUSTRY be pleased to state:

(a) whether it is a fact that Central Government Employees whose pay is

less than Rs. 300/- or 350/- P.M. are not eligible to apply for the allotment of Lambretta or Vespa Scooters;

- (b) if so, whether the allotment criteria are based on the pay of an incumbent or the nature of duties or the distance from the place of duty; and
- (c) if so, whether Government propose to modify the rules in this regard?

THE MINISTER OF INDUSTRY (SHRI D. SANJIVAYYA): (a) Applications for allotment of Lambretta and Vespa Scooters are not entertained from Central Government Employees whose basic pay is below Rs. 350/-per month. In the case of (1) Doctors, (2) Officers who have to perform predominantly field duties and (3) personal staff attached to Ministers and other high dignitaries of similar rank and officers of the rank of Joint Secretary above, applications are entertained, if they are drawing a basic pay of Rs. 300/- and above per month.

(b) and (c) For allotment of priority, the essentiality in terms of the nature of duties performed by the applicants and the capacity of the applicants for the purchase and maintenance of scooters are taken into consideration.
