(b) the latest position with regard to violent activities of the Khasi youths in the above district?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI V. C. SHUKLA): (a) According to the information received from the Assam Government they have unconfirmed reports that a good number of Khasi young men have crossed over the Indo-Pakistan Border for being trained in guerilla warfare.

(b) Violent activities have not so far come to notice.

## SCHOLARSHIPS FOR SCHEDULED CASTE AND SCHEDULED TRIBE STUDENTS

321. SHRI MAHAMMED HANEEF: Will the Minister of EDUCATION be pleased to state the number of Scholarships offered by Government to the students belonging to the Scheduled Castes and the Scheduled Tribes respectively during the current year and the amount of each scholarship?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (DR. SHRIMATI T. S. SOUNDARAM RAMACHANDRAN): The exact number of scholarships awarded will be known only after the close of financial year 1966-67 as the schema is implemented by the State Governments .

The amount of scholarship at present includes: —

- (i) monthly maintenance charges which vary from Rs. 40 for hostellers and Rs. 27 for day scholars in the Pre-University/ Intermediate and Degree courses to Rs. 75 for Hostellers and Rs. 60 for day-scholars in the professional degree courses in Medicine, Engineering etc. depending upon the course of study;
- (ii) all non-refundable compulsory fees like enrolment/registra-

- tion, tuition, games, library, medical, examination etc., payable by the student to the Institution or 'University/ Board;
- (iii) study tour charges upto a maximum <sub>0</sub>f Rs. 100 per annum to a student studying in professional course; and
- (iv) thesis typing/printing charges upto a maximum of Rs. 100 to a research scholar
