## COMPLAINTS AGAINST THE EMPLOYEES OF I.C.C.R.

- 332. SHRI V. M. CHORDIA: Will the Minister of EDUCATION be pleas ed to state:
- (•a) whether any complaints of corruption, abuse of power and misconduct against the employees of the Indian Council for Cultural Relations were received by Government during the last five years; and
- (b) if so, how many, and what action was taken by Government in each case?

THE MINISTER OF INFORMATION BROADCASTING (SHRI RAJ BAHADUR): (a) Yes, Sir. Complaints, mostly anonymous, in respect of employees of the Indian Council for Cultural Relations were received.

(b) lit is not feasible to give the number. Generally, the complaints were passed on for necessary action to the Indian Council for Cultural Relations, because as an autonomous body, it is for 'the Governing Body of the Council to take action in respect of its emolovees.

In 1964, the then President of the Council appointed a committee under chairmanship of Dr. C. D. Deshmukh 'to investigate into the complaints received against the Secretary of the Council. The Committee conducted a thorough inquiry and came to the conclusion that on the whole the allegations were false and did not call for any action against th« Secretary of the Council.

In July, 1964, one complaint was rs-ferred to the Special Police Establishment. The Vigilance Commission, Central considering the report of the Special Police Establishment advised that no case was made out for action against the employees in question.
