The matter is under further examination.

## TOKEN STRIKE BY GOVERNMENT **EMPLOYEES**

- 351. SHRI NIREN GHOSH: Will the Minister of HOME AFT'AIRS be pleased to state:
- (a) whether Government's attention has been drawn to the call of the Confederation of the Central Government Employees for one day token strike in the second week of November:
- (b) if so, what is the purpose of this call; and
- (c) the steps taken by Government to meet the demands of the employees?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI V. C. SHUKLA): (a) Yes, Sir.

- (b) The purpose of the proposed action is reported to be to focus the attention of the Government on the demand of the Confederation for neutralisation of rise in the cost of living and evolution of a fair Dearness Allowance formula.
- (c) On the basis of the recommendations of the Gajendragadkar Commission, Government have sanctioned increase in Dearness Allowance to the Central Government Employees, drawing pay less than Rs. 1000 per month and the increased rates take effect from 1st December, 1965. A further increase has also been sanctioned with effect from 1st August, 1966 in accordance with the recommendation of the Commission. The larger issue of evolving a formula for the grant of Dearness Allowance and other steps

for assisting Government employees to face the rise in the cost of living in future is one of the terms referred to the Gajendragadkar Commission, whose further report is awaited

## SEMINAR ON WOMEN'S EDUCATION AND COMMUNITY DEVELOPMENT

THE DEPUTY MINISTER IN THE MINISTRY OF **EDUCATION** (DR. SHRIMATI **SOUNDARAM** Т S. RAMACHANDRAN): The International Seminar on Women's Education Community Development, held in September 1966 only discussed certain problems of mutual interest to find a common approach to their solutions. The Seminar made no specific recommendations. The question, therefore, of Government's reaction to the commendations does not arise.
