THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI V. C. SHUKLA): (a) and (b). Dr. L. M. Singhvi, M.P., sent a letter to the former Home Minister bringing to his notice the smuggling of Chinese goods into the markets of Assam, existence of a strong pro-Chinese pocket in Assam and the financial assistance being received by them. In the letter it was also alleged that these saboteurs were instigating acts of violence against the Rajasthanis who had settled in Assam.
