ANTANI: Sir, I rise to make a submission that on the 5th of May I gave a calling attention notice in respect of the Ministry of External Affairs about the reported announcement by the Vice-President of Tanzania, Sheikh Karume, that from 1st of June if Indian shopkeepers settled in Zanzibar carrying on business for centuries did not contribute satisfactorily to voluntary labour in their farms, their licences will not be renewed from that date. That means if their licences are not renewed, their centuries old business will be wiped out. This is one more attempt to squeeze business from Indian shopkeepers, Indian nationals, settled there for centuries. Today is the 16th of May and there is no statement coming forth from the External Affairs Mniistry. I therefore request that before the House adjourns some statement should be made by the Minister for External Affairs.
