THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): Except for military withdrawals and disengagement, restoration of normal diplomatic relations, exchange of prisoners of war and limited resumption of postal and telecommunication links, the progress on implementation of other provisions of the Tashkent Declaration is held up as Pakistan does not seem interested in further normalisation of relations between the two countries.
