**गृह-कार्य मंत्री (श्री गुलजारी लाल नन्दा) :**

(क) भारत सरकार ने जम्मू और काश्मीर सरकार को लिख दिया है कि जो व्यक्ति हाल के संघर्ष में पाकिस्तान अथवा पाकिस्तानी कब्जे के क्षेत्र में चले गये थे उन्हें वापिस लौटने की इजाजत न दी जाय।

(ख) अगस्त-सितम्बर 1965 में संघर्ष के बाद जम्मू और काश्मीर सरकार ने उन क्षेत्रों के निवासियों के लिये पहिचान-पत्र जारी कर दिये, जिनमें से पाकिस्तान अथवा पाकिस्तानी कब्जे के क्षेत्रों को लोग गये थे। राज्य सरकार ने ऐसी हिदायते जारी की हैं कि यदि ऐसा कोई व्यक्ति उस क्षेत्र में मिले जिसके पास पहिचान-पत्र न हो तो उसके खिलाफ़ कार्यवाही की जाय।

†[THE MINISTER OF HOME AFFAIRS (SHRI GULGAZRI LAL NAND) : (a) Government of India have communicated to the Government of Jammu and Kashmir that persons who migrated to Pakistan or Pakistan-occupied area during the recent conflict are not to be allowed to return.

(b) After the hostilities in August-September 1965, the Government of Jammu and Kashmir issued identity cards to persons living in areas from which there was migration to Pakistan or Pakistan-occupied area. The State Government have issued instructions to take action if any person without an identity card is found in the area.]

**SHORE TRANSMITTING SET AT GOA PORT**

(a) whether a licence has since been issued to Goa Port authorities for establishing a
